The provision is also to meet expenditure towards strengthening of State Nodal Agencies (SNAs), setting up of National Meat & Poultry Processing Board, Indian Grape Processing Board and expenditure on Establishment related matters.

The provision is for providing assistance in the shape of Grants and other charges etc. for infrastructure facilities for the components - Mega Food Parks, Integrated Cold Chain Facility, Value Added Centres, Irradiation facilities and Establishment/ Modernization of Abattoirs. 3. The provision is made for providing assistance in the shape of grants-in-aid and other charges etc. for (i) Scheme for Technology Upgradation, Establishment and modernization of Food Processing Industries, (ii) Scheme for Upgradation of Quality of Street Food, (iii) Scheme for Human Resource Development, (iv) Scheme for Quality Assurance, Codex Standards, Research and Development and other Promotional Activities, (v) Setting up of National Institute of Food Technology Entrepreneurship and Management (NIFTEM) at Kundli (Haryana).
